

Dr. Gondolf reconsiders his own research in light of criticisms, and takes a careful look at research supporting the movement toward evidenced-based treatment for domestic violence. Regardless of where you stand on this issue, this is a great resource that gathers most of the previous work that has been done, gives you tools to use in evaluating, and offers arguments for a reasoned approach to treatment.
